## Hospice Remembers September 11

Hospice of Volusia/Flagler joined the nation in remembering September 11 with a Remembrance Ceremony attended by area dignitaries and many residents held on the banks of the lake adjacent to our Care Center in Port Orange.

The ceremony, broadcast live by WROD radio, featured prayers by Hospice Chaplains Leslie Avchin and Bob Kicklighter, music by Susan Rousseau, RN, and Maryann Douglas, a DBCC student and former Miss Port Orange. Participants were moved by Hospice Grief Counselor Shannon Andersen's recollections of her service to those directly affected by the World Trade Center destruction in the days after the attacks. The ceremony was placed in perspective in remarks delivered by Halifax•Fish Community Health Director of Corporate Communications John E. Evans, who said:

"We want to remember those ordinary people, whose ages spanned generations, whose education, occupation and wealth mirrored the diversity of our society, who a year ago today, became the first victims of the first attacks on American soil, and to honor their countrymen whose rescue and recovery efforts have established them as modern heroes and patriots.

"We present to the community a tangible reminder of those symbols of this historic date – a piece of the World Trade Center twin towers. Bill Hall of Hospice, who cherishes the strength we draw from our history, read of the way in which most of the debris from Ground Zero was being disposed of, and thought that as a monument to those who perished and those who rose as one to assure that the value of those lives would be preserved, a piece of the buildings had great and lasting value.

"Florida Senator Bill Nelson agreed and sought the assistance of New York Senator Charles Schumer's office, which led to New York Mayor Mike Bloomberg who authorized the three-foot, 300 pound section of I beam be released to Hospice for use in education and as a memorial. And it is both. You can't look at it and not get a sense of the enormity of the tragedy that brought it to the ground, or the magnitude of the effort it took to pull these great weights aside as the search for survivors, and then remains, ensued. It adds reality to the photos and films we have seen, and meaning to what we have seen in them.

"And for us, today, the beam symbolizes more. It is nicked and dented. It obviously has seen trauma. Yet like our national spirit, it is not bent, its structural strength remains, and like our freedoms, it will endure for years to come. In this quiet setting, by a lake, near woods, this beam has the power to evoke in our minds the sounds of sirens, the voices crying out for help or in search of loved ones; the spectacle of horror from which new national resolve has grown and flourished."

## Letter from the Executive Director

I received the following story from a friend of mine through an electronic mailing. The author is unknown. When I read it, I knew I wanted to share it with you.

### The Cab Ride

I drive a cab for a living. One night when I responded to a call, I arrived at 2:30 a.m., the building was dark except for a single light in a ground floor window. Under these circumstances, many drivers would just honk once or twice, wait a minute, then drive away. But I had seen too many impoverished people who depended on taxis as their only means of transportation. Unless a situation smelled of danger, I always went to the door. This passenger might be someone who needs my assistance, I reasoned to myself.

So I walked to the door and knocked. "Just a minute," answered a frail, elderly voice. I could hear something being dragged across the floor. After a long pause, the door opened. A small woman in her 80s stood before me. She was wearing a print dress and a pillbox hat with a veil pinned on it, like somebody out of a 1940s movie. By her side was a small nylon suitcase. The apartment looked as if no one had lived in it for years. All the furniture was covered with sheets. There were no clocks on the walls, no knickknacks or utensils on the counters. In the corner was a cardboard box filled with photos and glassware.

"Would you carry my bag out to the car?" she said. I took the suitcase to the cab, then returned to assist the woman. She took my arm and we walked slowly toward the curb. She kept thanking me

for my kindness. "It's nothing," I told her. "I just try to treat my passengers the way I would want my mother treated." "Oh, you're such a good boy," she said. When we got in the cab, she gave me an address, then asked, "Could you drive through downtown?" "It's not the shortest way," I answered quickly. "Oh, I don't mind," she said. "I'm in no hurry. I'm on my way to a hospice." "I looked in the rearview mirror. Her eyes were glistening. "I don't have any family left," she continued. "The doctor says I don't have very long."

I quietly reached over and shut off the meter. "What route would you like me to take?" I asked. For the next two hours, we drove through the city. She showed me the building where she had once worked as an elevator operator. We drove through the neighborhood where she and her husband had lived when they were newlyweds. She had me pull up in front of a furniture warehouse that had once been a ballroom where she had gone dancing as a girl. Sometimes she'd ask me to slow in front of a particular building or corner and would sit staring into the darkness, saying nothing. As the first hint of sun was creasing the horizon, she suddenly said, "I'm tired. Let's go now."

We drove in silence to the address she had given me. It was a low building, like a small convalescent home, with a driveway that passed under a portico. Two orderlies came out to the cab as soon as we pulled up. They were solicitous and intent, watching her every move. They must have been expecting her. I opened the trunk and took the small suitcase to the door. The woman was already seated in a wheelchair. "How much do I owe you?" she asked, reaching into her purse. "Nothing," I said. "You have to make a living," she answered. "There are other passengers," I responded. Almost without thinking, I bent and gave her a hug. She held onto me tightly. "You gave an old woman a little moment of joy," she said. "Thank you." I squeezed her hand, then walked into the dim morning light. Behind me, a door shut. It was the sound of the closing of a life. I didn't pickup any more passengers that shift. I drove aimlessly, lost in thought. For the rest of that day, I could hardly talk. What if that woman had gotten an angry driver, or one who was impatient to end his shift? What if I had refused to take the run, or had honked once, then driven away? On a quick

review, I don't think that I have done anything more important in my life. We're conditioned to think that our lives revolve around great moments. But great moments often catch us unaware – beautifully wrapped in what others may consider a small one. **People may not remember exactly what you did, or what you said, — but — they will always remember how you made them feel.**

As we are about to celebrate Thanksgiving 2002, I must count among my blessings the many wonderful staff and volunteers of Hospice of Volusia/Flagler who "go the extra mile" for patients and families as part of their daily activities. It is my continued privilege to be part of an organization that makes the small moments count so much. Thank you, staff and volunteers, who understand the concepts of service and compassion so well. May you be richly rewarded in all you do.

## In Their Own Words...

This is a new column that features articles written by Hospice of Volusia/Flagler patients, family members, or friends telling about their experiences with Hospice.

*The following article was based on an interview with Kathy Walter, the wife of Bill Walter, who was a patient of Hospice of Volusia/Flagler until his death in 1998. After Bill died, Kathy and her children moved to Colorado where Kathy is now a volunteer at the Hospice of Larimer County. This article was written for the Hospice of Larimer County, and appears here with their permission.*

### Angels in Our Agony

For Kathy Walter, whose husband died of melanoma in November of 1998, a live-in hospice center seemed to be heaven sent. The services her family received there helped ease the pain.

Bill was 36 then. Kathy was 35. For four years she and their children and other family members had watched in sorrow as Bill’s condition gradually declined, then suddenly worsened. When long-term strain collided with the trauma of the final weeks of Bill’s struggle to live, Kathy began to feel somewhat like a single parent – a lone adult on difficult duty, stressed to the breaking point in trying to maintain a life with an 18-month old daughter, a son age 5, a wonderful husband who was waning and tons of grief and fear in her soul.

At a residential hospice in Port Orange, the family found a calm, sane atmosphere in which they could breathe easier, get expert help in attending to Bill’s needs and gather strength for the final wind-down. The Walters, who had lived in Fort Collins for many years, were moved to Florida by the Loveland Company Bill was working for in April 1998 – just six months before he passed away.

Parts of that last half-year were positive for the fam-

ily. The bonds of their love grew stronger. They created lasting memories.

In other ways the experience seemed like a slow-motion train wreck. For two months Bill was in and out of a hospital, suffering from brain hemorrhages and a proliferation of tumors in his abdomen. The medical care was technically good but narrow in focus. “The doctors and nurses addressed Bill’s physical needs but didn’t look at the whole picture,” Kathy says. “They didn’t really think about the family members’ needs. They were busy. At times we felt like we were inconveniencing them. The situation was often frantic.”

Eventually the family turned to Hospice of Volusia/Flagler for help. That brought knowledgeable, caring folks into the Walter home. But Bill, fading fast, was in more and more pain.

“The hospice visitors were helpful,” Kathy says. “By then, however, I felt I could not provide adequate care for my husband – and I was the main caregiver. It was chaotic. We had people coming and going, and it was just crazy with having to keep track of medicines and other details. My mother-in-law, who was with us, was a nurse, and even she couldn’t do it all. I was not totally alone, of course, but I kind of felt alone in the enormity of it. It was scary because if I would move Bill a certain way, he would cry out, and I was never sure if I was getting the medication right.”

Inside a week of traditional hospice care, the family began to consider the residential option offered in that community.

“It was the strangest thing,” says Bill’s mother, Pat. “Two years before we lost our son, an elderly lady in our church was dying of cancer. We were in such a turmoil, even then, that for some reason I didn’t think of such a facility for us. Billy wasn’t at that stage yet – or so it seemed, I suppose.

Later, when it started getting extremely difficult for Billy, I spent a few nights with him, and on one of those nights I said a prayer before going to sleep. I asked God to give us guidance. The first thought that came to me in the morning was of that hospice care center.”

At first Bill and Kathy were hesitant to move. But when the facility staff explained what the center could provide, the family decided to try it. A tour of the place left them well impressed. The next 16 days, Bill’s last, were a godsend to him and his family.

The 16-bed Volusia/Flagler facility has a sunny atrium and a main gathering area with a fireplace, library, large aquarium and attractive hanging quilt. Each family living space has a patio. A patient’s bed can be rolled out into sunshine where the trickling of landscaped waterfalls and the singing of birds fill the air. The family hung pictures of their own on their living area walls. They brought in other items from home. Even the family dog, a golden retriever named Auburn, was welcomed with open arms. This was a particular comfort to Bill. Hospice volunteers brought in meals, cared for the kids and helped the family know what to expect in the dying process. Kathy believes this is why her children are doing well in the aftermath.

“The staff promoted good communication,” she says. “We were all talking about what was going to be happening. It was as if we were embracing it. The hospice people were always asking, “How are you holding up?” or “How are you doing?” This was very warm and inviting, where hospitals, as we learned, can be cold and sterile.”

Kathy and the children, who have returned to Fort Collins, still grieve for Bill. How could it be otherwise? The loss is massive. Yet she and they are moving on, and they have nothing but favorable memories of the way they were treated in the Florida hospice.

“It was an answer to our prayers,” Kathy says. “It was like a haven, the next best place to heaven literally, very calming, very quieting. We did not feel rushed or appear to be a bother or inconvenience to anyone. The hospice people – specially trained individuals who could better accommodate our needs – were there to serve us, not only Bill but the entire family. This was soothing and reassuring to me. It was as if those people were angels, and with clergymen of ours who were with us there as well, it was, all in all, a beautiful spiritual experience. Bill was much better served than he would have been if we had continued at home.”

Pat agrees. “Those people saved our lives,” she says. “Being at home with little children is not

a good situation to be in when you are trying to rest, and Bill was in need of much more than rest. He was dying, and that was hard to do at home. Kathy tried to keep everything as normal as possible, but it just couldn’t be done. When you have someone dying, you can’t maintain anything like normal home life.”

Should there be a place like Hospice of Volusia/Flagler in the Fort Collins-Loveland area? “Definitely,” says Kathy. “I hope the organization here can create a facility with the same atmosphere that we experienced. There is a real need for it – and I might point out that hospice care, residential or otherwise, is not just for the elderly. People tend to think of it as something just for 80-year-olds. As my situation shows, this is not the case,” says Kathy.



## Health Ministry of Hospice of Volusia/Flagler

At the beginning of the 20th century, only four percent of the American population was age 65 or older. By the year 2050, that number will rise to 20 percent of our population. A cultural value that we all embrace is to do all we can to ensure that our elder residents can remain at home and receive care from loved ones for as long as possible.

Virtually all primary caregivers of older adults need support and practical assistance to “prevent caregiver burnout.” Caregivers who provide continuous and intense care for “carees” who are chronically ill are at

information on how to make their jobs easier. Caregivers are referred to, as “the silent sufferers” and this program will help ease that burden. A trained “substitute caregiver” may be provided upon request, at no charge, so that a caregiver may participate in *Caregiver Health Ministry* sessions.

The caregiver programs are funded, in part by State of Florida, Department of Elder Affairs, Family Caregiver Support Program, in concert with the Area Agency on Aging, through a mini-grant awarded to Hospice of Volusia/Flagler.

a greater risk of developing depression, insomnia, back pain, stomach disorders and heart disease. Often times a heroic caregiver becomes more frail than the one being cared for because of the ongoing stress related to their caregiving responsibilities.

*Health Ministry of Hospice of Volusia/Flagler* provides two programs of assistance and training to help meet both caregiving and caregiver needs within Volusia County. These programs are available to faith-based congregations and are provided free of charge.

One program, *Caregiver Health Ministry*, provides services to family caregivers who come together through this ministry to gain support, education and

The second program, *Faith-in-Action Health Ministry* helps reinforce the growing community need for well-trained volunteers to care for the homebound. Over 1,100 Faith in Action programs exist nationwide and are made possible by grants from The Robert Wood Johnson Foundation. The Faith in Action network is committed to interfaith volunteer caregiving programs. Hospice of Volusia/Flagler was awarded a grant in May 2002.

*Faith-in-Action* volunteers provide a ministry to the sick which supports primary caregivers. They are generally highly motivated people whose energy and positive attitudes are a way to express their faith.

Volunteers are provided opportunities to develop new skills, meet new people, and make valuable contributions to their congregations and to the community. “Love Thy Neighbor” is the basis of the *Faith-in-Action* program.

*Health Ministry of Hospice of Volusia/Flagler* is a completely new program to address emotional and spiritual pain of the elderly and emphasize quality of life. We’ve partnered with faith-based congregations, social service, health and civic organizations around the issue of providing volunteer care to homebound persons and providing training and support to at-risk caregivers.

## A Special Wish Comes True

In September of 2001, June East age 65 was admitted to Hospice of Volusia/Flagler. June was a very sweet lady who told me she had experienced a very hard life. She and I developed a very trusting relationship in which she discussed her life and all of her trials and tribulations. June told me “Before I die, I would like to see all of my children again.” She told me it had been years since she had seen her children, and she loved them very much.

I conveyed this message to Chaplain Pam Stewart at the Good Samaritan Center, a skilled nursing facility, where June was staying, and we made plans to make June’s wish come true. Hospice has a Special Wish Fund to help with financial support for last wishes of our dying patients.

In February just before the Daytona 500 race, June’s condition started to decline. Due to the race crowds, all flights were booked and hotels were full. Both Pam and I were feeling somewhat discouraged, when we decided to approach this problem from another direction. Travel arrangements for the patient’s children were made with Greyhound Bus Line, and Comfort Inn and Suites discounted two rooms to accommodate them.

James and Edward East and Debbie White arrived in Daytona just prior to the Daytona 500. They spent three days with their mother, laughing and crying. They all expressed appreciation for Hospice enabling

them to spend time together. While they were here, Good Samaritan Center provided meals for James, Edward, and Debbie at no charge. It was truly a team effort to make this patient’s wish come true. Spirits were healed with love and forgiveness.

One month later, June died quietly and peacefully while I held her hand. Just before she died she said, “I will always remember Hospice. You’re an angel who made my dream come true.” I will always remember her with a special place in my heart and I am thankful everyday to work for such a wonderful organization that touches people’s lives and hearts daily.
